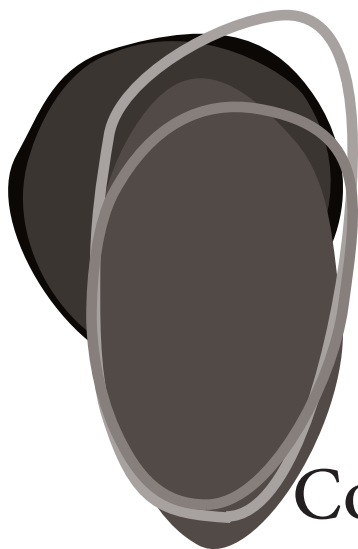

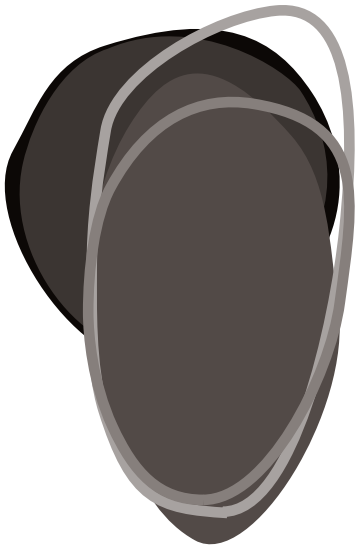

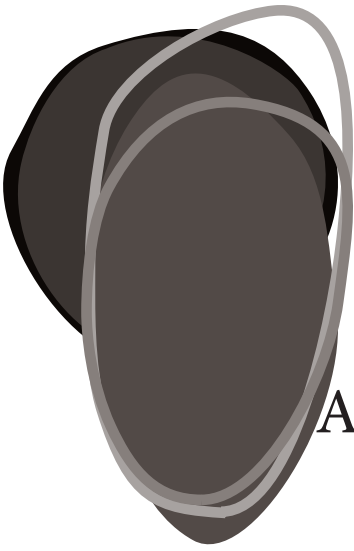


About the Editors
